PROGRAM INFORMATION:

1. This is an outreach, competitive league that consists of teams split between A, B and Legends divisions.
A Division: Teams employ specific offense and defense plays with experienced members who have competed in organized/officiated city, church, or recreational leagues.
B Division: Teams employ some offense and defense plays with members who have competed in a few organized city, church, or recreational leagues.
Legends Division: Open to anyone who is at least 40 years of age by Dec 31, 2018. **Restriction: A maximum of TWO players between the ages of 35-39 may be on the roster.**
2. League Begins: September 9, 2018 and ends on November 18, 2018.
3. Games will be played at ONE location (see **LOCATION** below). Games are played with two 20-minute halves with stop clock for the last 2 minutes of each half, with 4 minutes overtime.
4. League Playoff Days: November 4, 11, and 18, 2018 (*subject to change based on the number of teams*).
5. Cost¹: Early bird registration fee is \$695. Regular registration fee is \$795. PayPal payment is preferred. However, ONE check per team will be accepted as well (*subject to CFF Refund Policy*²). Make checks payable to Chang Family Foundation.
6. Each team must have a Captain and an Assistant Captain.
7. **Teams will be assigned to provide scorekeepers for other scheduled games before or after their scheduled game each week.**
8. Uniforms: Light and dark colored numbered uniforms are required. No duplicate numbers allowed.
9. **CELEBRATION:** November 17, 2018 (Time/Location TBD).

REGISTRATION FEE:

Must be received at the First Captains Meeting on **Sunday, August 26, 2018**.

TEAM ROSTERS:

Must be received no later than **Sunday, August 26, 2018**. Roster changes can be made up until the THIRD week of games.

Team Captain, please complete and submit the online Team Roster Form by the deadline. The roster form can be found at the CSL website.

HOLD HARMLESS & LEAGUE RULES FORMS:

Each player must sign the score sheet every week prior to participating in each game. Players that sign the score sheet will abide by the agreements outlined in the “Hold Harmless: Sportsmanship Contract & Release Form” section on the score sheet.

Teams are not officially entered into the league until completed TEAM ROSTER, TEAM NAME, and PAYMENT are received. Church name and/or affiliation may not appear in team name. Team rosters are frozen BEFORE the third game – September 23, 2018. Any roster changes after this date must be approved by the CSL Basketball Director and Core Team. Teams playing in the playoffs are able to use only players who participated in a minimum of FOUR (4) regular season games.

CAPTAINS MEETING:

Second Captains Meeting: **Saturday, October 13, 2018 – Location/Time TBD.** Each team MUST have a Captain and Assistant Captain present at these meetings. Captains are responsible for any material handed out or discussed.

² *Only 50% of the league fee will be refunded to those teams that drop out within one week of the start of the season. NO refunds will be issued to teams that drop out after the season starts.*
