### LEAGUE INFORMATION

- This is a Christian outreach, co-ed 6-on-6, competitive league that consists of Division A, B+, and B teams.  
**A Division:** Competitive level teams – team members are proficient in passing, setting, and spiking. Teams are able to run consistent offensive/defensive formations and plays comparable to an AAA high school level of play.  
**B+ Division:** Semi-competitive level teams – team members have basic passing, setting, and spiking skills. Teams use basic formations for offense and defense comparable to an A/AA high school level of play.  
**B Division:** Recreational level teams – team members have minimal to no experience in organized play.
- League begins **February 23, 2020** and ends on **May 17, 2020**. FOUR GAMES PER WEEK.
- Games are played on **Sundays** between **1:00-5:00pm** at the Bellevue Boys & Girls Club Hidden Valley Fieldhouse (1903 – 112<sup>th</sup> Ave NE, Bellevue WA 98004) and at the Tyee Community Gym (13630 SE Allen Road, Bellevue WA 98006). Game times and locations subject to change.
- There must be a minimum of six players, 14 years of age and over on each team roster. Maximum number of players on a team roster shall not exceed 15 players without prior permission from league director.
- League playoffs will be on **April 26** and **May 03** with the Championship games on **May 17**. Date/Time/Location for the CSL Celebration is TBD. Game times are subject to change.
- Cost per team is **\$540**. Payment must be received in full by **February 08, 2020** via PayPal only (unless other arrangements have been made). *\* If this represents a financial hardship please contact the Core Team.*

### REGISTRATION INFORMATION

- Registration starts **January 1, 2020**. Deadline for application submission is **January 18, 2020**. Both Captain and Assistant Captain applications need to be submitted by the deadline to be accepted.
- Rosters and League Fees are due on **February 08, 2020**.
- First Mandatory Captains and Assistant Captains Meeting** is scheduled for **Saturday, February 08, 2020** (10:00am @ Faith Bible Church).
- Second Mandatory Captains and Assistant Captains Meeting** is scheduled for **Saturday, March 28, 2020** (10:00am @ Tyee Community Gym).

All online applications, rosters, and payment must be submitted **NO LATER THAN 11:59pm** on the date they are due. Failure to meet the deadline may result in the team not being registered. Rosters may be updated after being submitted before the 3<sup>rd</sup> match of the season and with approval by the League Director.

**Please Note:** Applications submitted after the final registration deadline will be subject to a late fee. A \$50 administrative fee will be added to the registration fee.

### MANDATORY CAPTAIN AND ASSISTANT CAPTAIN MEETINGS

It is **required** that each team has both the Captain and Assistant Captain present at these meetings. They are both responsible for any material(s) handed out or discussed. Failure to attend training and captain meetings may result in league forfeiture.
